2. Eligibility

- a) The Advocates having minimum professional experience of at least Ten years, as practicing Advocate of High Court.
- b) Well conversant with City of Nagpur Corporation Act, Maharashtra Municipal Corporation Act & other important Corporation Concerned Acts.
- c) Having fluency in English & Marathi.

3. Terms and Conditions

- a. The advocate shall not necessarily be empanelled for specific court and shall have to accept the work assigned to him.
- b. Refusal by any Advocate to accept any work otherwise than on grounds of conflict of interest, may entail removal of such

advocate from the panel.

- c. The empanelled Advocates will not delegate/assign cases to others and has to deal with the case personally.
 - d. The empanelled Advocate shall maintain absolute secrecy and confidentiality about the cases of the Nagpur Municipal Corporation, Nagpur.
 - e. The empanelled Advocate should have proper and adequate infrastructure such as office premises, assistants, clerks, fax, mobile phone, internet connection etc.
 - f. The initial empanelment will be for one year. Performance of Empanelled advocates shall be reviewed from time to time. The Municipal Commissioner, Nagpur Municipal Corporation, Nagpur shall reserve the right to terminate the empanelment of any advocate at any time without assigning any reason.
 - g. Municipal Commissioner, Nagpur Municipal Corporation shall be the sole authority to decide the professional fee per case of empanelled Advocate and such decision shall be binding to all the empanelled advocates.
 - h. An undertaking shall be furnished by an advocate to the effect that all information furnished by him/her is correct.
 - i. An advocate shall not advise any party or accept any case against the Nagpur Municipal Corporation, Nagpur.
 - j. If the advocate happens to be a partner of a firm of lawyers or solicitors, it will be incumbent upon the firm not to entertain any case against the Nagpur Municipal Corporation arising in any court.
4.
