

You are requested to obtain licence from the Registering officer. The contract Labour (Registration and Abolition) Act, 1970, Nagpur Division Nagpur. For engaging workmen and contract labour under you failing which you will be held responsible for contravention of the provision under the said act. Act rules complication arising thereof.

- Note:
- 1) Site should be fully cleared after execution for health certificate is necessary.
  - 2) The contractor should provide safety measures for digging work.
  - 3) If, the under ground utility services i.e. Water pipe line, cable, sewer line, storm water drain line etc. are damaged during the execution work, the cost will be recovered from the bills of the contractors.
  - 4) Contractor will have to get the work insured form New India Insurance Co. Regional Office- 2 Udhav Building Dharmapeth, West High Court Road, Shankar Nagar, Nagpur or from any agency as directed by State Government from time to time. They should submit the receipt of premium paid, after issuance of work order / site allotment letter, failing which their bill will not be passed for payment. (Additional condition for the contract in tender)
  - 5) P.L. submits stamp paper worth Rs. 100/- for execution of agreement to Zone No. IX within 7 days.
  - 6) Splitting of work shall be the responsibility of A.E. SDE Concurred if any.
  - 7) The Contractor shall have to plant trees as per tender condition.
  - 8) The work being at the very lowest rate % Addl. S.D. will be deducted from that bill pl. note.
