Hon'ble Municipal Commissioner/Asstt. Commissioner/W.O. Dhantoli Zone No.4, Nagpur Municipal Corporation Nagpur, Vide his sanction dated 14/10/2016, has awarded the above mentioned work to you at 1% Below the estimated rates.

Please start the work immediately so that it is completed within the period of TWO Months. For further instructions, you are requested to contact Dy. Engineer, P.W.D. of this zone.

You are requested to obtain licence from the Registering officer under "The Contract Labour (Registration and Abolition) Act. 1970. Nagpur Division Nagpur" for engaging workmen and contract labour under you, failing which you will be held responsible for contravention of the provision under the said Act/Rules and complication arising thereof, if any.

Note: -

- 1) Site should be fully cleared after execution of work and for this certificate from Health Deptt. is necessary.
- 2) The contractor should provide safety measures for digging work, if any.
- 3) If the underground utility services i.e. water pipe line, cable, sewer line, storm water drain line etc. are damaged during the execution of work, the cost towards the same shall be recovered from the bills of the contractor.
- 4) Contractor will have to get the work insured from **United Insurance Co. Ltd. 19, Dharampeth Extension Shankar Nagar Chowk, Nagpur.** They should submit the receipt of premium paid, after issuance of work order/site allotment letter, failing which their bill will not be passed for payment. (Additional condition for the contract in tender)
- 5) Please submit stamp paper worth Rs. 100/- for execution of agreement to Zone No. 4 within 7 days from the receipt of Work Order.
- 6) Splitting of work, if any, shall be the responsibility of S.D.O. (P.W.D.) concerned.
- 7) No extension shall be granted except for genuine reasons.
- 8) 1 % Labour welfare cess will be deducted on executed estimate cost through every R.A. & Final Bill.
- 9) The Contractor Agree to Pay Additional S.D. for R.A. & Final Bill.
The Contractor Shall Have to Plant Trees as Per Tender Condition.
