 - 3) If, the under ground utility services i.e. Water pipe line, cable, sewer line, storm water drain line etc. are damaged during the execution work, the cost will be recovered from the bills of the contractors.
 - 4) Contractor will have to get the work insured form New India Insurance Co. Regional Office- 2 Udhan Building Dharmpath, West High Court Road, Shankar Nagar, Nagpur or from any agency as directed by State Government from time to time. They should submit the receipt of premium paid, after issuance of work order / site allotment letter, failing which their bill will not be passed for payment. (Additional condition for the contract in tender)
 - 5) PL. submits stamp paper worth Rs. 100/- for execution of agreement to Zone No. IX within 7 days.
 - 6) Splitting of work shall be the responsibility of A.E. SDE Councered if any.
