Nagpur Municipal Corporation (NMC), Nagpur is having its own Nuisance Detection Squad to regulate and curb the civil nuisance within the territorial jurisdiction of NMC. That, NMC is intending to strengthen the said squad by making contractual appointment of ex-servicemen of armed forces of India. The applications are hereby invited from the eligible candidates for the following contractual posts.

The interested and eligible candidates having may apply for the respective post and shall come for the interview along with duly filled prescribed application form and all the original requisite documents. The candidates shall have to submit duly filled in application forms at Old Administrative Building, Nagpur Municipal Corporation, Civil lines, Nagpur (MS) from 9.30 am to 05.00 pm on 05.02.2025 and interviews will be commenced from 9.30 am on 07.02.2025.

The Eligibility Criteria:

- 1. i)** Maximum Age : 50 years for Squad Zonal Leader as on dt. 05/02/2025 (Born on or after dt. 05/02/1975)
- ii)** Maximum Age : 50 years for Security Assistant as on dt. 05/02/2025 (Born on or after dt. 05/02/1975)

- 2.** Minimum service period with Armed forces should be 15 years and above.
- 3. i)** Certified copy of Discharge Book issued by the Defense Department.
- ii)** 2 (Two) Passport size photographs.
- iii)** Pension Payment Order (PPO)

1. In case of any dispute in short listing of candidates the decision of the Municipal Commissioner shall be final and binding to all.
2. A candidate must be of good health without any serious chronic ailment or physical Deformity. Selected candidates will be required to produced a medical fitness certificate from Registered Medical Officer/Practitioner to the appointing authority before joining.
3. Contract period is for the duration of 6 months and may be extendable by the NMC on the basis of Performance and requirement.
