Rs.39,97,068/- the Total cost of work is Rs.21,00,16,350/- Please start the work immediately so that it is completed within the period of Eightten Month.For further details/instruction you are requested to contact Executive Engineer.

You are requested to obtain license from the Registering officer, The Contract Labour (Registration and Abolition) Act. 1970 Nagpur, Division Nagpur, for engaging workmen and contact labour under you failing which you will be held responsible for contravention of the provision under the said act and rules and complications arising thereof.

- Note:**
- 1) Site should be fully cleared after execution of work and for this certificate from respective Health Officer be obtained.
 - 2) The contractor should provide all safety measures for digging work
 - 3) If, the underground utility services i.e. Water pipe line, cable sewer line, Storm water drain line etc. are damaged during the execution work, then cost will be recovered from the bills of the contractors.
 - 4) Contractors All Risks (CAR) Insurance policy & Workman Compensation Group Insurance Policy (WC) for the labours engaged to complete the work mentioned in the work order complet in all respect is required to be Purchased from Directorate of Insurance Nagpur Regional Office Room No.102.1st Floor Old Secretariat Building Civil Lines Nagpur.440001.They should submit the receipt of premium paid, after insurance of work order &before commencement of Work failing which their bill will not be passed for payment.
 - 5) Before receiving work order please confirm that an Agreement is duly signed by you.
 - 6) Contractor shall start the work only after the intimation to and consent of Exe.Engr.
 - 7) Contractor shall upload the photographs of the work at beginning of the work and at every Stage of the work
 - 8) Concerned Deputy Engineer shall confirm that work is not split up in different parts.
 - 9) Defect liability period (DLP) for this work is Ten Years.from the completion of work.
 - 10) The Payment Will only be Made after receipt of the Government Grant.
